Sealed Bids for the Camden-on-Gauley Summersville Clinic will be received by the Camden-on-Gauley Medical Center, Inc., located at 10003 Webster Road, Camden-on-Gauley, West Virginia, until 1:00 p.m., E.S.T., on Thursday, January 11, 2018 for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

The Scope of Work for the project generally includes renovation of an existing metal building structure for use as an outpatient health clinic. Exterior improvements to the building are generally cosmetic in nature and include replacement of damaged metal building panels estimated to be approximately 40% of the building exterior, recovering of the existing metal roof with insulation and a single ply membrane system, a new gutter and downspout system, and painting of all exterior walls. The building is divided into two sections, the Main St. side and the Water St. side. The majority of the interior renovation work shall take place on the Main St. side of the building. This interior renovation work includes removal of an attic level bearing on the walls below, removal and salvage of HVAC units, removal of ductwork, removal of light fixtures, removal of interior gypsum board and stud wall partitions, removal of floor finishes, and removal of mechanical, electrical, and plumbing fixtures, equipment, and distribution. Once the interior demolition has taken place, construction activities shall include new gypsum and metal stud wall partitions, new lay-in acoustic tile ceilings, new floor finishes, new doors and frames, painting, and new HVAC, plumbing, and electrical fixtures, equipment, and distribution. Existing concrete slab on grade to be saw cut for new utility routing. Renovation of the Water St. side of the building shall be limited to saw cutting of existing slab on grade concrete floors for two new plumbing distribution runs

The Work will be substantially completed by May 25, 2018. The portion of work on the Water Street side will be substantially completed by April 15, 2018. Final completion will be June 25, 2018. Liquidated damages shall be \$500.00 per day.

If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of thirty (30) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Bond payable to the Camden-on-Gauley Medical Center, Inc., an amount equal to five percent (5%) of the Total Bid.
