Sealed Bids for the Gore Bus Garage will be received by the Purchasing Director of the Harrison County Board of Education, located at 445 W. Main Street, Harrison County, West Virginia, until 2:00 p.m., E.S.T., on Tuesday, January 16, 2018 for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Construction will include site development and a new building. The three bay, 3,480 SF structure will be comprised of a pre-engineered metal building with standard metal building exterior wall siding and insulation. The floor will be concrete slab-on-grade with radiant floor heating as an alternate. The roof will be standard metal building roof panels supported by the metal building structural members. Overhead sectional doors and hollow metal doors will be utilized. The building will include plumbing rough-ins and HVAC systems. Labor and materials for interior partitions, ceiling system, finishes, plumbing fixtures, all electrical work, and various other items will be by Owner and not in contract.

The Work will be substantially completed within 90 days after the date when the Contract Times commence to run, and completed and ready for final payment within 120 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500 per day.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of thirty (30) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Bond payable to the Harrison County Board of Education, an amount equal to five percent (5%) of the Total Bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Harrison County Board of Education reserves the right to reject any and all Bids.
