ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Alum Fork & Laurel Lick Waterline Extensions will be received, by the Lewis County Economic Development Authority located at **110 Center Avenue, 2nd Floor, Weston, Lewis County, West Virginia** until **2:00 p.m.** local time on February 20, 2018 at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

The Work will be substantially completed within **270** calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within **300** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$2,000.00** per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Alum Fork & Laurel Lick Waterline Extensions
Received by the Lewis County Economic Development Authority

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the Lewis County Economic Development Authority in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Lewis County Economic Development Authority reserves the right to reject any and all bids.

A **MANDATORY** pre-bid conference will be held at **12:00 noon**, local time on **February 5, 2018** at the **Lewis County Economic Development Authority** located at **110 Center Avenue, 2nd Floor, Weston, Lewis County, WV**. Questions will be reviewed until noon on February 13, 2018.
