ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Davis Creek Crossing will be received, by the South Charleston Sanitary Board, located at 1 Rockcrest Drive Box 8336, South Charleston, Kanawha County, West Virginia until **10:00 AM** local time on **March 6, 2018**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Installation of approximately 110 LF of 8-inch ductile iron sewer pipe, approximately 100 LF of 16-inch Coated Steel Casing, steel and concrete supports, expansion joint, erosion and sediment controls, site restoration, and all miscellaneous appurtenances as shown on the drawings, specified in the specifications and required for a complete and operational sewer system.

The Work will be completed and ready for final payment within 90 calendar days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day for final completion.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Separation of Storm Drains from the Sanitary Sewer – Phase I
Received by the South Charleston Sanitary Board

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to South Charleston Sanitary Board in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code and a City of South Charleston Contractor’s License.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The South Charleston Sanitary Board reserves the right to reject any and all bids.

A mandatory pre-bid conference will be held at **10:00 AM** local time on **February 21, 2018** at the South Charleston Sanitary Board located at 1 Rockcrest Drive Box 8336, South Charleston, WV. All prospective bidder must attend conference and a site visit to the project site. Bids will not be accepted from those who do not attend the pre-bid conference in its entirety.
