ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Contract #3 – Proposed Water Treatment Plant Upgrades and Improvements will be received, by the Town of Middlebourne, located at 211 Stealey Street, Middlebourne, Tyler County, West Virginia until 2:00 pm local time on Tuesday, March 20, 2018, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

The Work will be substantially completed within 180 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 210 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – #3 Proposed Water Treatment Plant Upgrades and Improvements
Received by the Town of Middlebourne

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the Town of Middlebourne in an amount equal to five percent (5%) of the base bid.

Nondiscrimination in Employment - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Town of Middlebourne reserves the right to reject any and all bids.

A pre-bid conference will be held at 10:00 am local time on Tuesday, March 6, 2018, at the Town of Middlebourne located at 211 Stealey Street, Middlebourne, West Virginia. Attendance at the pre-bid conference is highly encouraged but is not mandatory. Close of Questions will be at noon, Tuesday, March 13, 2018.
