ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of sewer lift stations improvements will be received, by the Greenbrier Public Service District #2 located at the PSD office at 405 Tom Raines Drive, Rainelle, WV 25962 until **10:00 a.m.** local time on July 26, 2017 at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Electrical and carpentry work associated with new electrical controls for eight (8) sanitary sewer lift stations and installation of three (3) emergency generators. Construction will include raising the controls and electrical components above the flood stage that was experienced in the area last fall.

The Work will be substantially completed within 90 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 120 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500 per day.

The Issuing Office for the Bidding Documents is: The Thrasher Group, Inc., 155 Blue Angel Lane, Beaver, WV 25813. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Amounts paid are not subject to refund.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Sewer Lift Station Improvements
Received by the Greenbrier PSD #2

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Greenbrier PSD #2 in an amount equal to five percent (5%) of the base bid.

Nondiscrimination in Employment - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Greenbrier PSD #2 reserves the right to reject any and all bids.

A pre-bid conference will be held at **10:00 a.m.** local time on **July 18, 2017** at the Greenbrier PSD #2 offices located at 405 Tom Raines Drive, Rainelle, WV. Attendance at the pre-bid conference is mandatory.
