Sealed Bids for Contract Proposed Sidewalks Phase VII will be received by the City of Pleasant Valley, 2340 Kingmont Road, Pleasant Valley, Marion County, West Virginia, until 2:00 p.m., L.P.T., on Tuesday, September 26, 2017, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Install 482 LF concrete curb and gutter, 368 SY concrete sidewalk including retaining wall under sidewalk, 400 LF 15" HDPE pipe, 3 drainage inlets, asphalt repair, and miscellaneous items along Pleasant Valley Road.

The Work will be substantially completed within 75 days after the date when the Contract Times commence to run, and completed and ready for final payment within 90 days after the date when the Contract Times commence to run. The liquidated damages shall be based off of the WVDOH Table 108.7.1 Schedule of Liquidated Damages in the WVDOH Standard Specifications.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the City of Pleasant Valley, an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia contractor's license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The City of Pleasant Valley reserves the right to reject any and all Bids.
