Sealed Bids for Beckley Police Department will be received by the City of Beckley, 409 S. Kanawha Street, Beckley, Kanawha County, West Virginia, until 10:30 a.m., L.P.T., on Friday, October 20, 2017, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Construction will include site development and a new building. The two story, 24,500 SF structure will be comprised of steel framing with structural metal stud infill at the exterior walls and stair towers of concrete masonry units. The ground floor will be concrete slab-on-grade and the second floor will be poured-in-place concrete on metal deck supported by steel joists. The roof will be metal deck supported by steel beams with rigid insulation and EPDM. Exterior cladding will be face brick and cast stone. Aluminum storefront systems will be utilized for the exterior fenestration while the interior doors will be primarily hollow metal frames with solid core wood doors. Interior partitions will be light gauge metal stud and drywall. Finishes will include painted drywall, carpet tile, VCT, LVT, and ceramic tile. Ceilings will be a combination of suspended drywall and acoustic ceilings. The building will include electrical and data systems, lighting, plumbing and HVAC systems.

The Work will be substantially completed within 210 days after the date when the Contract Times commence to run, and completed and ready for final payment within 240 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the City of Beckley, an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia contractor's license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The City of Beckley reserves the right to reject any and all Bids.
