The approximate quantities of Work to be Bid upon is as described as follows:

Liquidated damages shall be \$1,000.00 per day.

The Work for <u>Contract #2 – RV Park Utilities</u> will be substantially completed within <u>90 days</u> after the date when the Contract Times commence to run, and completed and ready for final payment within <u>120 days</u> after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Bond payable to the Doddridge County Parks and Recreation Commission, an amount equal to five percent (5%) of the Total Bid.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code at the time of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.
