

## **ADVERTISEMENT FOR BIDS**

### **BERKELEY COUNTY PUBLIC SERVICE SEWER DISTRICT BERKELEY COUNTY, WEST VIRGINIA PROPOSED CONTRACT #6 – RIVERSIDE WWTP CONSOLIDATION THRASHER PROJECT # 101-020-1525**

Sealed bids for Contract #6 – Riverside WWTP Consolidation will be received by the Berkeley County Public Service Sewer District, Berkeley County, West Virginia, until 2:00 p.m., L.P.T., on June 13, 2018, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of work to be bid upon are described as follows:

1. The work includes the installation of 1 LS for Mobilization/Demobilization; 1 LS for Pre-Construction Video of Project Area; 1 LS for Erosion and Sediment Erosion Control; 3,820 LF of 12" PVC SDR-35 Gravity Sewer Line; 260 LF of 8" 8" PVC SDR-35 Gravity Sewer Line; 140 LF of 4" PVC SDR-35 Service Lateral Pipe; 13,450 LF of 8" PVC C900 CL 166 Force Main; 3,450 LF of 6" PVC C900 CL 166 Force Main; 2,355 LF of 3" PVC SDR-21 Class-200 Force Main; 70 LF of 24" Steel Casing (Bore & Jack); 450 LF of 16" Steel Casing (Bore & Jack); 90 LF of 16" Steel Casing (Open Cut); 50 LF of 12" Steel Casing (Open Cut); 35 LF of 6" Steel Casing (Open Cut); 18 EA of 48" Diameter Manholes w/Standard Frame and Covers; 9 EA of 48" Diameter Manholes w/Watertight Frame and Covers; 30 VF of 48" Diameter Manhole Riser Sections; 5 EA of Interior Drop Manhole Connections; 10 EA of PVC Wye Connections; 14 EA of Air Release Valve Assemblies; 13 EA of Force Main Cleanouts; 5 EA of Connections of New/Existing Sewer to Existing Manholes; 3 EA of Connection of Existing Sewer to New Sewer Outside New Manhole; 375 LF of WVDOH Type "B" Trench; 3,615 LF of WVDOH Type "C" Trench; 19,300 LF of Reclamation of Disturbed Area; 1 LS for Marlowe #1 Pump Station; 1 LS for Marlowe #2 Pump Station; 1 LS for Marlowe #3 Pump Station; 1 LS for Demolition of Existing Riverside Package WWTP; 1 LS for Demolition of Existing Brookfield Package WWTP; 1 LS for Demolition of Existing Broad Lane Package WWTP; and all necessary appurtenances to complete the Work.

The Work will be substantially completed within 270 days after the date when the Contract Times commence to run, and completed and ready for final payment within 300 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00/day.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Berkeley County Public Service Sewer District, for an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia contractor's license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Berkeley County Public Service Sewer District reserves the right to reject any and all Bids.
