SKY VIEW WATER STORAGE TANK REHABILITATION PROJECT

Sealed bids for Sky View Water Storage Tank Rehabilitation Project will be received by The Thrasher Group, Inc., located at 300 Association Drive, Charleston, Kanawha County, West Virginia, until **2:00 p.m.**, local time, on June 5, 2018, for furnishing labor and materials and performing all Work set forth in the Contract Documents. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of work to be bid upon are described as follows:

The work consists of rehabilitating the existing 150,000 and 75,000 gallon Sky View elevated water storage tanks. The work includes lead paint abatement, coating the interior and exterior of the water storage tanks, and miscellaneous repairs to the water storage tanks per specification section 099050.

The Work will be substantially completed within 120 days after the date when the Contract Times commence to run, and completed and ready for final payment within 150 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00/day.

Prospective Bidders may examine the Bidding Documents at the issuing office Monday through Friday between the hours of 8:00 am to 5:00 pm and may obtain copies of the Bidding Documents from the issuing office as described below.

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

All Bidders are required to have a current West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

Preferences for prospective bidders doing business in the City of Weirton will NOT be considered for this project.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Weirton Area Water Board, for an amount equal to five percent (5%) of the Total Bid.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Weirton Area Water Board reserves the right to reject any and all Bids.

A Pre-Bid conference will NOT be held for this project.
