Sealed Bids for the Central West Virginia Regional Airport Authority Security Enhancements will be received by the Central West Virginia Regional Airport Authority, located at 100 Airport Road, Suite 175, Charleston, Kanawha County, West Virginia, until **2:00 p.m., L.P.T., on Monday July 9, 2018**, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The scope of work for this project shall include the replacement of the existing card access and video surveillance systems in their entirety as indicated on the drawings. This shall include, but not limited to, the complete removal of the existing systems and supporting infrastructure; furnishing and installing new system components such as all hardware and software for the head-end, cameras, video monitors, door hardware, card readers, fiber optic and category 6 cable and associated components, etc. required for a complete and integrated system. Also, the scope of work shall include all components and associated infrastructure required for the replacement of perimeter fence, (approximately 860LF, man gates, vehicle gates) microwave detection system at several locations as indicated on the drawings.

The Work will be substantially completed within 150 days after the date when the Contract Times commence to run, and completed and ready for final payment within 200 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Central West Virginia Regional Airport Authority, an amount equal to five percent (5%) of the base Bid.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Central West Virginia Regional Airport Authority reserves the right to reject any and all Bids.
