Sealed Bids for the Raleigh County Airport Authority, Runway 1-19 Rehabilitation will be received by the Raleigh County Airport Authority, located at 176 Airport Circle, Beaver, Raleigh County, West Virginia, until **2:00 p.m., L.P.T., on Monday July 9, 2018**, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

The proposed project will consist of a milling of existing asphalt runway and applying 2” overlay of an area consisting of 119,696 SY. The work will also involve repairing cracks, grooving of the runway and permanent runway pavement markings.

The Work will be substantially completed within 60 days after the date when the Contract Times commence to run, and completed and ready for final payment within 90 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.
