Sealed Bids for the construction of the **Commercial Avenue Rehabilitation** will be received, by the **Village Administrator of Mingo Junction**, at their office at **501 Commercial St., Mingo Junction, OH, 43938**, until **1:00 pm** local time on **August 2nd, 2018**, at which time the Bids received will be publicly opened and read.

The work to be bid upon is described as follows:

The resurfacing of Commercial Avenue in Mingo Junction starting in front of the water treatment plant and continuing north along Commercial Avenue 0.45 miles to the butt joint just south of the Cross Creek Bridge. Work to include milling and resurfacing of the roadway, full-depth pavement repairs, installation of curb ramps, curb, sidewalk, new pavement markings, guardrail upgrades and other work indicated in the Contract Documents.

The Work will be substantially completed within 60 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 90 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of thirty (30) days after the date set for the opening of bids.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond for the full amount of the bid, in accordance with Section 153.571 of the Ohio Revised Code. Bid security furnished in bond form, shall be issued by a surety company or corporation licensed in the State of Ohio to provide said surety.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.
