Sealed Bids for the construction of the Concrete Ceiling Repair will be received by Grafton Housing Authority, 131 East Main Street Grafton, Taylor County, West Virginia, until **2:00pm**, **L.P.T., on Tuesday August 28, 2018**, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of work to be bid upon are described as follows:

Repairing approximately 60 SF of concrete ceiling by cleaning and applying a concrete patch. Additional support for the ceiling will be included and will consist of timber construction and other Work indicated in the Contract Documents.

The Work will be substantially completed within 30 calendar days after the date when the Contract Times commence to run and completed and ready for final payment within 45 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Grafton Housing Authority in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.
