Sealed Bids for the Contract #1 – Lodge Roof Replacement and Contract #2- Misc. Park Paving will be received by the Doddridge County Parks and Recreation Commission, located at PO Box 426 1252 Snowbird Road, West Union, Doddridge County, West Virginia, until 2:00 p.m., L.P.T., on Thursday, September 13, 2018 for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Contract #1 – Lodge Roof Replacement

Provide all labor, materials, equipment, tools, fees, bonds, taxes and insurance to replace the existing roof the park lodge as detailed in the construction documents and specifications as provided by The Thrasher Group, Inc. The roof is approx. 6,000 SF in area and shall be replaced in a seamless metal roof and will also include installation of new sheathing on approximately a third of the roof.

Contract #2 – Misc. Park Paving

The misc. park paving will consist of leveling and overlaying an existing parking lot, installing stone, asphalt base and wearing surface on the RV road and pad, and leveling and applying an asphalt overlay to the existing basketball and tennis courts. The courts will also require an acrylic surface. Approximately 1500 tons of asphalt.

The Work for **Contract #1 – Lodge Roof Replacement** will be substantially completed within **60 days** after the date when the Contract Times commence to run, and completed and ready for final payment within **75 days** after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

The Work for **Contract #2 – Misc. Park Paving** will be substantially completed within **45 days** after the date when the Contract Times commence to run, and completed and ready for final payment within **60 days** after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Bond payable to the Doddridge County Parks and Recreation Commission, an amount equal to five percent (5%) of the Total Bid.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code at the time of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Doddridge Co. Park and Recreation Commission reserves the right to reject any and all Bids.

A pre-bid conference for both Projects will be held at the Doddridge Co. Park, located at 1252 Snowbird Rd., West Union, Doddridge County, West Virginia, on **Wednesday, September 5, 2018, at 10:00 a.m. for Contract #1 and 10:30 a.m. for Contract #2.**
