ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Quarry Development Landslide Repair will be received, by the City of Clarksburg at Clarksburg City Hall, located at 222 W Main St, Clarksburg, WV, until 2pm, local time on Tuesday, October 2, 2018, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Construction of 230 LF of a H-Pile wall and 183 CY of earthwork to repair the slip along Quarry Drive. Additional construction will include 16 TN of shoulder stone to repair the existing shoulder, 20 TN of wearing course, 40 TN of HMA Type I Base course, 90 TN of Class I Aggregate Base Course for repair of Quarry Drive itself.

The Work will be substantially completed within 120 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 135 days after the date when the Contract Times commence to run.

A two-envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on: Quarry Development Landslide Repair
Received by the City of Clarksburg

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of sixty (60) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the City of Clarksburg, in an amount equal to five percent (5%) of the base bid.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section 521-11-11 of the West Virginia Code.

Contractor will be responsible for paying the City's 2% B&O Tax and will be required to obtain a building permit from the City's Code Enforcement Office. Permit fee will be waived by the City.

The City of Clarksburg will afford full opportunity to disadvantaged business enterprises to submit a show of interest in response to this invitation and will not discriminate against any interested company or individual on the grounds of race, color, sex, handicap or national origin in the contract award.

The City of Clarksburg reserves the right to reject any and all bids.

A pre-bid conference will be held at 10am local time on Thursday, September 20, 2018 at the project location on Quarry Drive. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
