ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the RMS-Contract # 1-New Richmond Water Line will be received, by the Ravencliff-McGraws-Saulsville Public Service District, at the **Wyoming County Commission Office** located at **155 Park Street, Pineville, Wyoming County, West Virginia** until **2:30 PM** local time on **October 30<sup>th</sup>, 2018**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Approximately 7,000 lf pf 8-inch water line, 7,500 lf of 6-inch water line, 4,400 lf of 2-inch water line, filter media replacement at the water treatment plant, flow control building improvements, fencing at the existing booster stations and related construction.

The Work will be substantially completed within 180 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 210 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder  
Bid on Contract – RMS-Contract # 1-New Richmond Water Line  
Received by the Ravencliff-McGraws-Saulsville Public Service District

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Ravencliff-McGraws-Saulsville Public Service District in an amount equal to five percent (5%) of the base bid.

Nondiscrimination in Employment - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Ravenscliff-McGraws-Saulsville Public Service District reserves the right to reject any and all bids.

A pre-bid conference will be held at the **Wyoming County Commission Office** on **October 11<sup>th</sup>, 2018 at 1:00 PM** local time. The Wyoming County Commission Office is located at **155 Park Street, Pineville, Wyoming County, West Virginia**. The pre-bid meeting will be held in the meeting room that is located in the old elementary school. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
