The approximate quantities of Work to be Bid upon is as described as follows:

This contract will include but not limited to site work consisting of 6,010 CY of over-excavation for a proposed aquaponics facility, site improvements including drainage, sidewalk, asphalt road, and parking lot, 1,090 linear feet of 1.25" force main, lift station, and 1,168 linear feet of 2" waterline. Construction work shall include an approximately 11,000 gross square foot, preengineered greenhouse clad with a combination of metal and polycarbonate panels. HVAC systems, environmental controls, electrical work, and plumbing required for operation of the facility shall also be included in the Work.
