The Benedum Airport Authority will be constructing an addition to their existing Terminal totaling approximately 500 square feet to house new TSA Equipment. The addition will be located under the existing metal canopy roof. The roof area of the extent of the addition will receive rigid insulation and EPDM membrane roofing. The exterior walls will be metal stud framed, continuous insulation, with metal siding finish; a new ductless mini-split system will provide HVAC. Lighting and power will be accommodated in the addition.

The Work will be substantially completed within 30 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 15 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.
