Sealed Bids for the Contract Retaining Wall Stabilization at Grafton H.S. will be received by the Taylor County Board of Education, located at 1 Rose Street, Grafton, Taylor County, West Virginia, until 2:00 p.m., L.P.T., on Thursday, May 9, 2019 for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Provide all labor, materials, equipment, tools, fees, bonds, taxes and insurance to stabilize approximately 20 LF of existing brick retaining wall with steel beams and plates.

The Work for Contract Retaining Wall Stabilization will be substantially completed within **30 days** after the date when the Contract Times commence to run and completed and ready for final payment within **45 days** after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first, and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Bond payable to the Taylor County Board of Education, an amount equal to five percent (5%) of the Total Bid.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code at the time of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

Taylor County Board of Education reserves the right to reject any and all Bids.
