Sealed Bids for Doddridge Elementary School Middle School Entrance & Parking Improvements will be received by the Doddridge County Board of Education at their offices, located at 1117 WV Route 18 North, West Union, WV, until 2:00 p.m., L.P.T., on Tuesday, June 18, 2019, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

Construction of extending the left turn lane into the Middle School off of Rt. 50, adding acceleration lanes heading both in the east and westbound directions of Rt. 50, construction of a parking lot and egress road behind the Middle School. Approximately 900 CY of aggregate base stone, 1600 TN of asphalt, traffic control, 514 LF of glare barrier, and several misc. items.

The Work will be substantially completed by August 23, 2019. Liquidated damages shall be \$1,000.00 per calendar day.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Doddridge County Board of Education, for an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia contractor's license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

Doddridge County Board of Education reserves the right to reject any and all Bids.
