Sealed Bids for the Renovation of Deicing Facility will be received by the Benedum Airport Authority, located at 2000 Aviation Way, Bridgeport, Harrison County, West Virginia, until **2:00 p.m., L.P.T., on Wednesday June 26<sup>th</sup>, 2019**, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

The proposed project will consist of installing upgrading the existing de-icing system with new valves and outlet pipe, and construction of an additional 820 linear feet of 12" trench drain, 410 linear feet 18" CPP, 366 linear feet 24" CPP, and 9 inlets.

The Work will be substantially completed within 60 days after the date when the Contract Times commence to run, and completed and ready for final payment within 75 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

A two envelope system will be used.

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.
