ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Ivy Branch Off-Road Park Abandoned Mine Lands Pilot Project** will be received by the Hatfield McCoy Regional Recreation Authority, located at **179 Rita Mall Road, Man, Logan County, West Virginia** until **1:00 p.m.** local time on **July 2, 2019**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Install 7 36" HDPE mine seal bat gate closures, 2,000 linear feet of temporary access road, 400 linear feet of riprap vee ditch, 1,600 linear feet of super silt fence, 3 stream road crossings, and 1,000 cubic yards of unclassified excavation.

The Work will be substantially completed within 45 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 60 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000 per day.

The Issuing Office for the Bidding Documents is: The Thrasher Group, Inc., 600 White Oaks Blvd., Bridgeport, WV 26330. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Ivy Branch Off-Road Park
Received by the Hatfield McCoy Regional Recreation Authority

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Hatfield McCoy Regional Recreation Authority in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Hatfield McCoy Regional Recreation Authority reserves the right to reject any and all bids.

A mandatory pre-bid conference will be held at 10:00 a.m. local time on Wednesday, June 26th, 2019 at the Hatfield McCoy Welcome Center located at 28 Big Pinnacle Branch Road, Julian, WV. Attendance at the pre-bid conference is mandatory.

Prospective Bidders are advised that the contract awarded under this bid is to be funded in whole or in part by the Hatfield McCoy Regional Recreation Authority and the West Virginia Department of Environmental Protection – Office of Abandoned Mine Lands and Reclamation.

Bidders must comply with the President’s Executive Order Nos. 11246 and 11375, which prohibit discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Anti-Kickback Act, Section 3 Segregated Facilities, Section 109, the Contract Work Hours Standard Act and the “Buy American Act,” which will be discussed at the Pre-Bid and in the addendum.

Bidders must certify that they do not and will not maintain or provide for their employees any facilities that are segregated on the basis of race, color, creed or national origin. Federal Law prohibits discrimination on the grounds of race, color, national origin, religion, age, handicap and sex in this project. Minority firms are particularly encouraged to participate.

USE OF MINORITY, WOMEN’S AND SMALL BUSINESS ENTERPRISES

Should the Contractor intend to sublet a portion of the work on this project, it shall seek out and consider minority, women and small business enterprises as potential subcontractors. The Contractor shall contact minority, women’s and small businesses to solicit their interest, capability, and prices, and shall retain proper documentation to substantiate such contacts.

The Contractor will sign and provide the Minority, Women’s and Small Business Affirmative Action Certification to DEP along with the name(s) of any subcontractor(s) it submits for approval.
