ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Improvements to Kovach Tank and Upgrades to Compton Booster Pump Station will be received, by the City of Bridgeport, located at 515 West Main Street, Bridgeport, Harrison County, West Virginia until 2:00 pm local time on Tuesday, October 22, 2019, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Mobilization/Demobilization, Video Taping of Project Area, Installation of 8" Ductile Iron Bypass Piping at the Kovach Tank, Installation of an 8" Check Valve Vault at the Kovach Tank, Installation of an Altitude Valve Vault at the Kovach Tank, Abandonment of an Underground Booster Pump Station at the Kovach Tank, Removal and Replacement of Steel Doors at the Compton Booster Pump Station and Installation of an Exhaust Fan and Duct work at the Compton Booster Pump Station.

The Work will be substantially completed within 90 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 105 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500 per day.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Improvements to Kovach Tank and Upgrades to Compton Booster
Pump Station
Received by the City of Bridgeport

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the City of Bridgeport in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The City of Bridgeport reserves the right to reject any and all bids.

A pre-bid conference will be held at 2:00 pm local time on Tuesday, October 8, 2019 at the City of Bridgeport, located at 515 West Main Street, Bridgeport, WV. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
