Sealed Bids for East Park Elementary School Auditorium Ceiling Renovations will be received by the Marion County Board of Education at their Maintenance Facility, located at 28 12th Street, Fairmont, WV 26554, until 10:00 a.m., L.P.T., on October 1, 2019, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

The work consists of demolition of the school's existing 40'x60' auditorium plaster / wood lath ceiling and associated light fixtures and construction of new of 2x2 lay-in drop ceiling and 2x2 LED light fixtures.

The Work will be substantially completed within 23 consecutive calendar days and final completion within 30 calendar days. Liquidated damages shall be \$500.00 per calendar day.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of fifteen (15) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Marion County Board of Education, for an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia contractor's license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

Marion County Board of Education reserves the right to reject any and all Bids.
