ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Pleasant Valley Park - Phase 3A will be received, by the City of Pleasant Valley at their office located at 2340 Kingmont Road, Fairmont, Marion County, WV 26554 until **2:00 P.M.** local time on **Thursday, November 7, 2019** at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Proposed Pleasant Valley Park – Phase 3A will consist regrading existing earth slope and stabilizing with rip rap stone, adding a permanent earthen berm to direct stormwater, installing two (2) drainage inlets, and approximately 100 LF of storm pipe tying into existing inlet structures. The project will also involve constructing a walking trail that is approximately 1400 feet long surfaced with stone, and some miscellaneous items.

The Work will be substantially completed within 45 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 60 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Envelope No. 1 must have the following information presented on the front:

Received by the City of Pleasant Valley

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to City of Pleasant Valley in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The City of Pleasant Valley reserves the right to reject any and all bids.
