ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Waste Water Systems Improvements Project will be received, by the Town of Ellenboro, located at 789 E. Washington Avenue, Ellenboro, Ritchie County, West Virginia until 2:00 pm local time on Wednesday, December 4, 2019, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

1 LS Mobilization/Demobilization, 1 LS Videotaping of Project Area, 1 LS Sand Filter Repairs, 225 TN Sand Filter Media #57 Stone, 225 TN Sand Filter Media #4 Stone, 775 TN Sand Filter Media Sand, 1 LS Removal of Barscreen/Splitter Box, 1LS Headworks, 1 LS Headworks Building, 1 LS Site Piping, 2 EA Plug Valves, 1 EA Gantry Crane, 1 LS Gabion Wall and 1 LS Reclamation and miscellaneous appurtenances.

The Work will be substantially completed within 75 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 105 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder  
Bid on Contract #2 – Upgrades to the Waste Water Treatment Plant  
Received by the Town of Ellenboro

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Town of Ellenboro in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Town of Ellenboro reserves the right to reject any and all bids.

A pre-bid conference will be held at 10:00 am local time on **Wednesday, November 20, 2019**, at the Town of Ellenboro Town Hall located at 789 E. Washington Avenue, Ellenboro, WV. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
