Sealed Bids for the construction of Contract #5 – Existing Lift Station #10 Improvements will be received by the Malden Public Service District, located at the Malden Baptist Church, 200 Wise Drive, Charleston, Kanawha County, West Virginia until 3:00 p.m. local time on November 21, 2019, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

1 LS Mobilization/Demobilization; 1 LS Videotaping of Project Area; 1 LS Erosion and Sediment Control; 220 LF Remove and Replace 8" PVC Gravity Sewer; 230 LF Remove and Replace DI Gravity Sewer; 3 EA Remove and Replace Existing Manholes w/ New 48" Diameter MH Base, Cone Top, Regular Watertight Casting; 6 VF 48" Diameter Manhole Riser Pipe; 1 EA Tie-In to Existing Pump Station; 1 EA Tie- In to Existing Sewer Line; and 1 LS Lift Station #10 Improvements: Remove and Dispose of Existing Chain link Fence Surrounding Lift Station, Install and Maintain By-pass Pumping System as Required During Improvements, Remove Existing Wooden Posts and Rail from Wet Well to Control Panel Structure Including Conduit and Steel box, Remove Existing Wet Well Concrete Top and Install 8 ft. Vertical and 8 ft. Diameter Casting (Including Mastic Sealant), Remove the Two (2) Existing Raw Sewage Pumps and Replace with Two (2) Flygt CP 3127 HT3-483, 10 HP Raw Sewage Pumps, Remove Existing Pump Guide Rails and Install New Stainless Steel Guide Rails to Match New Wet Well Top Elevation, Reinstall Existing Concrete Top on Wet Well with Mastic Sealant, Attach Pump Cable Float Box to Top of Wet Well, Remove Existing Valve Vault Concrete Top and Install 8 ft. Vertical and 4 ft. Diameter Casting (Including Mastic Sealant), Reinstall Existing Concrete Top on Valve Vault with Mastic Sealant, Install 8 ft. Vertical Extension for By-Pass Pump Connection, Fill in Area to Elevation Shown and Install Filter Fabric and Site Stone, Install 2" PVC Schedule 40 Conduit Underground from Wet Well to Control Panel Structure and Install New Float Cables, Install 6 ft. Chain link Fence and Two (2) 6 ft. Wide Swing Gates, Raise Electric Meter 3 ft. Vertical on the Control Panel Structure, Replace Two (2) Existing 4" Gate Valves with Two (2) New Gate Plug Valves, Replace Two (2) Existing Check Valves with Two (2) New Check Valves, Replace the Existing Manhole Frame and Cover Located in the Dry Branch Road with a Water Tight Frame and Cover as Shown on the Drawings, and Reclamation of Disturbed Area.

The Work will be substantially completed within <u>90</u> days after the date when the Contract Times commence to run, and completed and ready for final payment within <u>120</u> days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00/day.

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Malden PSD, in an amount equal to five percent (5%) of the base bid.

<u>Nondiscrimination in Employment</u> - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

<u>Suspension and Debarment</u> - Recipient shall not entertain the use of businesses that are listed on the "Excluded Parties List System" at <u>www.wpls.gov</u>. In accordance with 2 CFR Part 1532 and Subpart B and C of 2 CFR Part 180.

Prospective Bidders should note that this contract will include the following critical requirements as identified in the contract documents:

- 1. Affirmative Action Program Requirements and Goals.
- 2. Certificate of Non-Segregated Facilities.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.
