Sealed Bids for the construction of the Arlington/Glen Falls Water Line Improvement Project will be received by the Clarksburg Water Board, located at 1001 South Chestnut Street, Harrison County, West Virginia, until **2:00 pm** local time on **Thursday, March 12, 2020** at which time the Bids received will be publicly opened and read.

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

Bids may not be withdrawn for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Clarksburg Water Board in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Clarksburg Water Board reserves the right to reject any and all bids.

A pre-bid conference will be held at **10:00 am** local time on **Thursday, February 20, 2020**, beginning at Clarksburg Water Board, 1001 South Chestnut Street, Clarksburg, WV 26301, then continuing with a site visit immediately thereafter. Attendance at the pre-bid conference is highly encouraged but is not mandatory. Questions will be received by the Engineer until noon, Tuesday, March 3, 2020.
