Sealed Bids for the acquisition of the **Central WV Reginal Airport Authority - Snow Removal Dump Truck** will be received, **Central WV Reginal Airport Authority**, at their office located at 100 Airport Road, Suite 175 Charleston, WV 25311 until **2:00 PM** local time on **Wednesday, April 15, 2020** at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Acquisition of two (2) Snow Removal Dump Trucks with 16' front snowplow, spreader and right front wing plow.

The Work will be substantially completed within 300 calendar days after the date when the Contract Times commence to run and completed and ready for final payment within 330 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of one hundred twenty (120) days after the date set for the opening of bids.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Central WV Regional Airport Authority reserves the right to reject any and all bids.
