Sealed Bids for Contract Taxiway Lighting Upgrades will be received by the Benedum Airport Authority, located at the North Central West Virginia Airport, 2000 Aviation Way, Bridgeport, Harrison County, West Virginia, until 2:00 p.m., L.P.T., on Thursday, June 11, 2020, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The Work to be Bid upon is as described as follows:

Remove and replace existing 5KV, #8 AWG, Type C taxiway lighting cabling from airfield lighting vault to all of taxiway lighting fixtures. The new cabling will be 5KV, #8 AWG, Type C, XLPE insulation installed in the existing 2" PVC conduit/duct system. Remove and replace existing taxiway lights, base plates and isolation transformers. The intent is to re-use the existing base cans and conduit system as much as possible. The new fixtures will be specified with LED light sources without heating elements. Add fixture grounding to the existing base cans and to the new lighting fixtures. Add new fixtures and base cans to correct spacing issues, remove old base cans and reconnect conduit as necessary. Replacement of the airfield guidance signage that are presently powered off the taxiway edge lighting circuits. The new signage will have LED lighting sources.

The Work will be substantially completed within 90 days after the date when the Contract Times commence to run, and completed and ready for final payment within 100 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Benedum Airport Authority, an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia contractor’s license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Benedum Airport Authority reserves the right to reject any and all Bids.
