ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Contract #2 - Tank Upgrades will be received at the offices of The Thrasher Group, located at 600 White Oaks Blvd., Bridgeport, Harrison County, West Virginia, until 2:00 p.m., L.P.T., on Tuesday, July 14, 2020, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud and will also be available through live-stream. A link for the live-stream of the Bid Opening will be provided via Addendum.

The approximate quantities of work to be bid upon are described as follows:

1 LS Mobilization/Demobilization, 1 LS Erosion and Sediment Control, 1 LS One (1) 33' Tall x 42' Dia. 341,000 Gallon Water Storage Tank w/Concrete Foundation, 1 LS One (1) New Valve Vault for 341,000 Gallon Water Storage Tank (Including Piping, Valves, and Drainage), 25 EA 36" Diameter Drilled Caissons Foundation, 1 LS Hydrodynamic Mixing System, 1 LS Site Piping, 20 CY Dump Rock Gutter, 100 LF 2" Conduit for Fiber Optic/Telemetry for New Control Panel, 1 LS New Access Road Complete with all Drainage Structures and all Necessary Stone, 1 LS Site Work Clearing and Grubbing, Grading, Surface Preparation (Including Necessary Stone, Drainage and Retaining Wall), 600 LF 6' Tall Cyclone Fencing w/Two 6' Swing Gates, 135 LF 12" PVC C900 DR-18, 1 LS Cut and Plug Existing Water Line, 1 LS New Control Panel, 1 LS Demolish Existing 125,000 Gallon Tank, 15 CY Disposal of Oil-Field Sand, 1 LS Testing of Existing Sand, 1 LS Reclamation.

The Work will be substantially completed within 120 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 150 days after the date when the Contract Times commence to run. Liquidated damages shall be \$900 per calendar day.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Contract #2 – Tank Upgrades
Received by the Sun Valley Public Service District

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Sun Valley Public Service District in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Sun Valley Public Service District reserves the right to reject any and all bids.
