Sealed Bids for Doddridge County Middle School Science lab Upgrades will be received by the Doddridge County Board of Education at their offices, located at 268 Bulldog Drive, West Union, WV, until **2:00 p.m., L.P.T., on June 26, 2020**, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The Work to be Bid is generally described as follows:

Removal and replacement of existing science lab components, display boards, room finishes including flooring and ceilings, repainting of walls and associated elements, and some upgrades to existing mechanical, electrical and plumbing elements, and other Work indicated in the Contract Documents.

The Work will be Substantial Complete within 3 months after the date of the Notice To Proceed, and completed and ready for final payment within 30 days after the date of Substantial Completion. Liquidated damages shall be \$1,000.00 per calendar day.

Envelope No. 1 must have the following information presented on the front:

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these Contract Documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of sixty (60) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Doddridge County Board of Education, for an amount equal to five percent (5%) of the base Bid.

Bidders must hold a current West Virginia general contractor’s license on the date of Bid Opening.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

Doddridge County Board of Education reserves the right to reject any and all Bids.
