ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Security Fence Improvements at Duvall Rosier Field** will be received, by Fairmont State University, Attention Lenora Montgomery, Room 106 Facilities Building, 1201 Locust Avenue, Fairmont, WV 26554, until **2:00 p.m.** local time on **Friday, July 24, 2020**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Repairing existing fence around the Duvall Rosier Field (replace bent or damage aluminum fence, plum and/or replace existing stone columns). Work will also include adding additional fence and columns around the complex for security. Both man gates and vehicular gates will be installed. The vehicular gates by the Physical Plant will have keypad entrance and exit loops. A proposed 5' wide asphalt walkway will be bid as an alternative.

The Work will be substantially completed within 30 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 45 days after the date when the Contract Times commence to run. Liquidated damages shall be \$200.00 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Security Fence Improvements at Duvall Rosier Field
Received by the Fairmont State University

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of sixty (60) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Fairmont State University, in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

Fairmont State University reserves the right to reject any and all bids.
