Sealed Bids for the construction of the **Ivy Branch Phase II – Cabins** will be received, by the **Hatfield McCoy Regional Recreation Authority** at the office of **The Thrasher Group, Inc.** located at **300 Association Drive, Charleston, West Virginia** until **1:00 p.m.** local time on **July 30, 2020**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

*Clearing and grubbing, grading, construction of gravel parking area, and installation of utilities and drainage facilities.*

The Work will be substantially completed within sixty (60) calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within ninety (90) days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

Envelope No. 1 must have the following information presented on the front:

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of sixty (60) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Hatfield McCoy Regional Recreation Authority, in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Hatfield McCoy Regional Recreation Authority reserves the right to reject any and all bids.

A **MANDATORY** pre-bid conference will be held at **10:00 a.m.** local time on **Tuesday, July 21, 2020** at the **Hatfield McCoy Welcome Center parking lot** located at **28 Big Pinnacle Branch Road, Julian, West Virginia**. After meeting in the parking lot, project representatives and all prospective bidders will conduct a site visit.

Prospective Bidders are advised that the contract awarded under this bid is to be funded in whole or in part by HMRRA and the West Virginia Department of Environmental Protection – Office of Abandoned Mine Lands and Reclamation Economic Development Pilot Program.
