ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Water System Improvements Project, Contract #2 – 256,000 Gallon Storage Tank will be received at the offices of The Thrasher Group, located at 600 White Oaks Blvd., Bridgeport, Harrison County, West Virginia, until 2:00 p.m., L.P.T., on Thursday, August 20 2020, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud. Attendance at this bid opening will also be available through conference call. The conference call in number will be provided via Addendum.

The approximate quantities of work to be bid upon are described as follows:

1 LS Mobilization/Demobilization, 1 LS Erosion and Sediment Control, 256,000 Gallon Water Storage Tank, 265,000 Gallon Water Storage Tank Foundation, 256,000 Gallon Water Storage Tank Vault, Piping, Valves, etc. shown on the Site Plan, Tank Site Improvements, Tank Access Road, Potable Water Mixing System (Hinton Road Tank), Potable Water Mixing System (Main Tank) and other miscellaneous appurtenances.

The Work will be substantially completed within 225 calendar days after the date when the Contract Times commence to run and completed and ready for final payment within 30 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1000 per day.

Envelope No. 1 must have the following information presented on the front:

Received by the Town of Ellenboro

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first, and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Town of Ellenboro in an amount equal to five percent (5%) of the base bid and all alternates.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders and any and all subs are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Town of Ellenboro reserves the right to reject any and all bids.
