Sealed Bids for The Lodge at Geneva-on-the-Lake Pool Deck Expansion Project will be received and publicly opened at the offices of the Ashtabula County Commissioners, 25 West Jefferson St., 2nd floor Old Courthouse, Jefferson, Ashtabula County, Ohio 44047, until 2:00 p.m. on Friday, August 7, 2020. The scope of the project includes: furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc.

Base bid is as described as follows:

1 LS Mobilization, 1 LS Stormwater Protection, 1 LS Clearing and Grubbing, 1 LS Selective Demolition, 1 LS Storm Sewer, 1 LS Vertical Folding Door (base bid), 1 LS Vertical Folding Door (alternate bid# 1), 1 LS Retaining Wall, 1 LS Bar/Kitchen Pavilion, 1 LS Concrete Patio Expansion, 1 LS Game Courts, 1 LS Artificial Turf, 1 LS Cabanas, 1 LS Furniture (Cabanas), 1 LS Firepits, 1 LS 120V Light Post Relocation, 1 LS Low Voltage Lighting, 1 LS Aluminum Fencing, 1 LS Glass Fencing, 1 LS Landscape Plantings, 1 LS Seeding and Mulching, 1 LS Video Taping. Includes all labor, materials, permits, inspections and related products and services for the selective demolition of the existing structure/site and the installation of the proposed design elements as described above and as outlined in the plans and specifications.

Alternate I is described as follows:

1 LS - Vertical Folding Door #2. Includes all labor, materials, permits, inspections and related products and services for the selective demolition of the existing structure and installation of 'Vertical Folding Door #2' as outlined in the plans and specifications.

The Work will be substantially completed within 120 days after the date when the Contract Times commence to run, and completed and ready for final payment within 120 days after the date when the Contract Times commence to run. Liquidated damages shall be \$800.00 per day.

A non-mandatory pre-bid meeting will be held on Thursday, July 30th at 8:00 a.m. at the Lodge at Geneva-on-the-Lake. Bidders should check in with the front desk upon arrival.

Deadline for all questions will be Friday, July 31st at 5:00 p.m.

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR- 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be publicly opened. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A Bidder may not withdraw his Bid for a period of ninety (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a certified check or Bid Bond payable to the Ashtabula County Commissioners, an amount equal to five percent (5%) of the base Bid.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Ashtabula County Board of Commissioners reserves the right to waive any and all informalities and the right to reject any and all bids.
