Sealed Bids for the construction of the Contract #1 – Pool Parking Lot and Contract #2 – Splash Park will be received, Doddridge County Parks & Recreation Commission, at the office located at 1252 Snowbird Road, West Union, Doddridge County, West Virginia, until 2:00 p.m., L.P.T., on Tuesday, September 1, 2020, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

## Contract #1 – Pool Parking Lot

Provide all labor, materials, equipment, tools, fees, bonds, taxes and insurance to construct a parking lot addition that will consist of approximately 45 new spaces, a bypass road, sidewalk, curbs, fill embankment, drainage system, lights, etc.

# Contract #2 – Splash Park

The installation and construction of a 2,600 SF splash park and kiddy pool. The project also consists of the construction of new 1,500 SF concession/restroom facility, renovation of an existing pool bathhouse, sidewalks, a concrete drive path, and several misc. items.

The Work will be completed by April 30, 2021. Liquidated damages shall be \$2,500.00 per day.

If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Doddridge County Parks & Recreation Commission

in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Doddridge County Parks & Recreation Commission reserves the right to reject any and all bids.
