ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Town of Capon Bridge Contract #1 - Proposed Wastewater Treatment Plant Extension will be received by the Town of Capon Bridge at the office of The Thrasher Group, Inc., located at 600 White Oaks Boulevard, P.O. Box 940 Bridgeport, Harrison County, WV 26330 until 2:00 pm local time on Wednesday, January 13, 2021. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud through live-stream, as social distancing guidelines will be followed. A link for the live-stream of the Bid Opening will be provided via Addendum.

The approximate quantities of work to be bid upon are described as follows:

The Wastewater Treatment Plant Expansion consists of installing a new 50,000 gallon per day wastewater treatment plant and updating the existing 50,000 gallon per day wastewater treatment plant. Work will include installing a new headworks, treatment plant, blowers and building, chlorine disinfection system, new lab building, site work, electrical, new emergency generator, erosion and sediment controls, scada system, an allotment for an upgrade to the electrical system and all ancillary mechanical, electrical, instrumentation and controls, erosion and sedimentation controls, civil and other items needed to provide a complete fully tested and operable system as shown in the plans and specifications.

The Work will be substantially completed within 240 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 270 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am to 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Town of Capon Bridge – Contract #1 - Proposed Wastewater
Treatment Plant Expansion
Received by the Town of Capon Bridge

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to the Town of Capon Bridge in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Town of Capon Bridge reserves the right to reject any and all bids.
