Sealed Bids for the construction of the Antoline Conservation Center Water and Sewerage Extensions will be received, by the Boy Scouts of America, located at 649 Jack Furst Drive, Glen Jean, Fayette County, West Virginia until 2 PM local time on Thursday, December 17, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

Approximately 1800 linear feet of DR-9 HDPE (DIPS, PE4710, 250 PSI) Waterline and 2800 linear feet of DR-17 HDPE (DIPS, PE4710, 125 PSI) Pressure Sewer Line and related appurtenances.

The Work will be substantially completed within 75 calendar days after the date when the Contract Times commence to run and will be completed and ready for final payment within 90 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1000.00 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Envelope No. 2 labeled "Bid Proposal" shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 "Bid Proposal", will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 "Bid Proposal" will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Boy Scouts of America in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Boy Scouts of America reserves the right to reject any and all bids.

A pre-bid conference will be held at 10:00 AM local time on Wednesday, November 18 at the Boy Scouts of America Ruby Welcome Center along US 19 near Glen Jean, Fayette County, WV 25846.
