ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Contract #PY – 2019 CDBG #B-F-19-1CT-1 (Activities 1, 4, 5, 6 & 7)** will be received, by **Tuscarawas County Commissioners**, at the office of the **Tuscarawas County Office Building located at 125 E High Ave, New Philadelphia, OH, 44663**, until **1:30 PM** local time on **Wednesday, February 10, 2021**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

1. Activity 1 – Warren Township Street Improvements. This Activity will include resurfacing approximately 2,763 linear feet of asphalt on TR 1189 (Lake Drive) and TR 319 (True Road) in the Warren Township. The Engineer's Estimate is \$41,810.00.
2. Activity 4 – Fairfield Township Street Improvements. This Activity will include resurfacing approximately 3,602 linear feet of asphalt on TR 315 (Riggle Hill Road) in the Fairfield Township. The Engineer's Estimate is \$58,672.50.
3. Activity 5 – Village of Port Washington Street Improvements. This Activity will include resurfacing approximately 1,493 linear feet of asphalt on Saint Clairsville Street in the Village of Port Washington. The Engineer's Estimate is \$28,140.00.
4. Activity 6 – Village of Tuscarawas Street Improvements. This Activity will include resurfacing approximately 754 linear feet of asphalt on Park Drive in the Village of Tuscarawas. The Engineer's Estimate is \$26,985.00.
5. Activity 7 – City of Uhrichsville Sidewalk Improvements. This Activity will include demolition and construction of approximately 268 linear feet of sidewalk adjacent to West 1st Street in the City of Uhrichsville. The Engineer's Estimate is \$37,291.70.

The Work will be substantially completed within **60** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **90** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$800.00** per day. Contract Documents may be examined at the following places:

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first, and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

Bids shall be accompanied by a certified check or bid bond payable to Tuscarawas County Commissioners, in an amount equal to ten percent (10%) of the base bid.

NONDISCRIMINATION IN EMPLOYMENT

Bidders on this work will be required to comply with the President’s Executive Order No. 11246. The requirements for bidders and contractors under this order are explained in the specifications.

SUSPENSION AND DEBARMENT

Under Executive Order 12549 a recipient shall not entertain the use of businesses that are listed on the “Excluded Parties List System (EPLS)” at www.epls.gov in accordance with regulation 40 CFR 32.510.

NOTICE OF FEDERAL WAGE REQUIREMENTS

Contractors are required to comply with all laws pertaining to federal prevailing wage rates issued in accordance with the Davis Bacon Act.

A Bidder may not withdraw his Bid for a period of thirty (30) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Guarantee as required by the contract.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.
