ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Water System Improvement Project – Contract #1-Proposed Water Line Replacement will be received, by the Paden City Municipal Water Works at the office of The Thrasher Group, Inc., located at 600 White Oaks Boulevard, P.O. Box 940 Bridgeport, Harrison County, WV 26330 until 2:00 pm local time on Thursday, March 4, 2021. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud through live-stream, as social distancing guidelines will be followed. A link for the live-stream of the Bid Opening will be provided via Addendum.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder

Bid on Contract – Water System Improvement Project
Contract #1 – Proposed Water Line Replacement

Received by the Paden City Municipal Water Works

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Paden City Municipal Water Works in an amount equal to five percent (5%) of the base bid.

Nondiscrimination in Employment - Bidders on this work will be required to comply with the President's Executive Order Number 11246 and the provisions of Executive Order No. 10925 as included therein. The requirements for bidders and contractors under this order are explained in the specifications.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Paden City Municipal Water Works reserves the right to reject any and all bids.
