2. **SEALED BIDS** for the above-referenced project will be received by the Owner at The Thrasher Group office located at 600 White Oaks Boulevard, Bridgeport, WV 26330 until **2:00 P.M. local time on Thursday, February 25, 2021**. No bids will be received after 2:00 P.M., at which time the Bids received will be publicly opened and read.
3. Due to COVID restrictions, the bid opening and reading will be available via a Microsoft Teams link that will be included with the **FINAL ADDENDUM**.
4. All questions must be submitted via email to Brad Messenger (bmessenger@thethrashergroup.com) by **Friday, February 19, 2021 (5:00 P.M. local time)**.
5. A **FINAL ADDENDUM** will be issued on **Monday, February 22, 2021**.
6. All work for this project shall be in accordance with the Thrasher specifications included with this project as well as the 2017 *West Virginia Department of Transportation Division of Highways (WVDOH) Standard Specifications Roads and Bridges* and the *2020 Supplemental Specifications*.
7. WVDOH fuel and asphalt indexes shall not apply to this project.

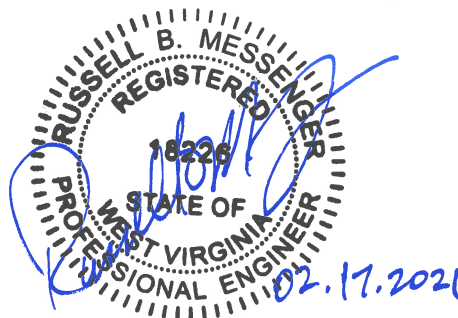
8. The Owner will provide a waste area for the project at the end of the existing pavement on the White Oaks Phase 3 entrance. The Contractor shall be responsible for any necessary erosion and sediment controls and grading performed at the waste area. Any waste that is placed on the site shall be placed, compacted, and graded smooth with positive drainage acceptable to the Owner and Engineer. All work associated with the waste area shall be bid incidental to Bid Item #3 (WVDOH Item #207001-001 Unclassified Excavation).
9. The Contractor shall be responsible to keep WV 131 and the White Oaks Phase 3 entrance road clear of mud and other debris to the satisfaction of the Owner and Engineer. All work associated with the cleaning the roadways shall be bid incidental to Bid Item #1 (WVDOH Item # 201001-000 Clearing and Grubbing).
10. Contractor shall coordinate activities to provide access and not disrupt activities on adjacent properties including but not limited to: Freedom Kia, WVDOH Park and Ride, Meadow View residential development, MonPower, and Harrison County Routes 73/5 and 73/9.
11. Construction stakeout and material testing for the project shall be provided by the Owner and performed by The Thrasher Group. When possible, the Contractor shall provide one week's notice for scheduling.
