#### TO WHOM IT MAY CONCERN:

This Addendum forms part of the Contract Documents and modifies the original Bidding Documents. The following are clarifications and responses to questions posed by contractors for the above reference project.

# A. <u>GENERAL</u>

1. See revised Bid form included with this addendum breaking out line-item costs for each roof separately and asbestos abatement. Also included is a key plan of the roofs.

# B. <u>SPECIFICATIONS</u>

- 1. REMOVE section 012100 Allowances from the specifications. There will be no allowances on this project.
- 2. A revised Index is included with this Addendum.

# C. <u>DRAWINGS</u>

1. On Sheet A1.01 REVISE reference note 1 to read "Install (1) layer of 2" polyiso insulation".

# D. <u>QUESTIONS AND RESPONSES</u>

#### **QUESTION**

1. Roof 2 that is mechanically fastened through the asbestos containing roof material is to be demolished where the mechanical fasteners shall be removed. Removing these fasteners will disturb the existing ACM. This work shall be executed by a licensed asbestos abatement contractor, correct? How should this abatement work be handled and what credentials are required?

#### RESPONSE

See clarification E.1 below.

## **QUESTION**

2. Is a coverboard required? If so, please specify coverboard to be used and attachment/securement method.

## RESPONSE

Yes, <sup>1</sup>/<sub>2</sub>" HD coverboard per the specifications.

## QUESTION

3. Can we strip in a drip edge or flange gutter instead of a term bar in the gutter? That detail would risk not being covered in warranty and also could cause other issues.

#### RESPONSE

Yes, that would be acceptable.

# E. <u>CLARIFICATIONS</u>

1. Along with the existing ballast, roofing membrane, fiberboard, and fasteners, the existing tar roofing shall be removed and disposed of as well down to the existing wood deck. Per the asbestos report included in Addendum 1, this material contains asbestos and shall be abated by a WV licensed asbestos abatement contractor and shall be legally disposed of at an approved asbestos disposal site. All work shall comply with WVDEP general requirements of the Asbestos NESHAP as applied to the Standard for Demolition and Renovation Operations. A separate line item for this cost is provided on the revised Bid form included with this addendum.

Although cost will be a major factor in contract award, the Harrison County Commission may award the contract at their sole discretion to any qualified bidder based on the best value and interest of the Harrison County Commission.

Owner reserves the right to reject any or all Bids, in whole or in part, including without limitation, nonconforming, nonresponsive, unbalanced, or conditional Bids, and waive any informality during the bidding process.
