Sealed Bids for Contract Jet Bridge Replacement will be received by the Central West Virginia Regional Airport Authority, Kanawha County, West Virginia, until 2:00 p.m., L.P.T., on Tuesday, May 25, 2021, for furnishing labor and materials and performing all Work set forth in the Contract Documents prepared by The Thrasher Group, Inc. Immediately following the scheduled closing time for the reception of Bids, all proposals which have been submitted in accordance with the conditions of the Contract Documents will be publicly opened and read aloud.

The approximate quantities of Work to be Bid upon is as described as follows:

The replacement of one (1) passenger boarding bridge (PBB) at Yeager Airport. The PBB is located at gate C2. The scope of work includes the procurement and installation of the new PBB, as well as the removal of existing equipment, including but not limited to pre-conditioned air units and ground power units. These items will be reinstalled on the new PBB. In addition, the scope includes removal of existing gate envelope striping and the reinstallation of new gate envelope striping.

The Work will be substantially completed within 300 days after the date when the Contract Times commence to run and completed and ready for final payment within 330 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500.00 per day.
