ADVERTISEMENT FOR BIDS**

Bids for the construction of the Preston County Schools 2021 Paving Program will be received, by Preston County Board of Education at 731 Preston Drive, Kingwood, Preston County, West Virginia, until **2:00 p.m., L.P.T., on Thursday, July 20, 2021**, at which time the Bids will be publicly opened and read.

The work to be bid upon is generally described as follows:

Preston County schools is requesting bids that include labor, material, taxes, equipment, and tools for the asphalt paving at Preston High School. The work will consist of milling and overlaying existing parking lot that will involve approximately 12,500 SY of milling and 1,850 tons of asphalt.

The Work will be substantially completed within 30 calendar days after the date when the Contract Times commence to run and completed and ready for final payment within 45 days after the date when the Contract Times commence to run. Liquidated damages shall be \$1,000.00 per day.

A bidder may not withdraw his bid for a period of sixty (60) days after the date set for the opening of bids.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor's License per Section §21-11-11 of the West Virginia Code.

A two-envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

- Name and address of Bidder
- Bid on: Preston County Schools 2021 Paving Program

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope No. 1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these bidding documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Preston County Board of Education reserves the right to reject any and all bids.

A pre-bid conference will be held at **10:00 am local time on Wednesday, June 30, 2021** at the Preston County Board of Education complex located at 731 Preston Drive, Kingwood, WV 26537. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
