ADVERTISEMENT FOR BIDS

Sealed Bids for the replacement of the Sand Filter Media will be received, by the Mountain Top Public Service District, located at 4150 Bismarck Road, Mount Storm, Grant County, West Virginia 26739 until **2:00 pm** local time on **Thursday August 5, 2021**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

1 LS Mobilization/Demobilization, 1 EA Remove Sand & Gravel Filter Media for Filter #1, 1 EA Remove Sand & Gravel Filter Media for Filter #2, 1 EA Install Sand & Gravel Filter Media in Filter #1, 1 EA Install Sand & Gravel Filter Media in Filter #2

The Work will be substantially completed within 45 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 75 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500 per day.

Envelope No. 1 must have the following information presented on the front:

Name and address of Bidder
Bid on Contract – Sand Filter Media Replacement
Received by the Mountain Top Public Service District

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Mountain Top Public Service District in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Mountain Top Public Service District reserves the right to reject any and all bids.
