Sealed Bids for the construction of the **Contract #PY-2021 CDBG #B-X-20-1BE-2** will be received by **The Harrison County Commissioners** at the **Commissioners' Office, 100 West Market Street, Cadiz, OH, 43907**, until **10:00 AM** local time on **October 13th, 2021**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

The project consists of the replacement of the existing clarifier equipment including the chain and flight system, drive units, valves, telescoping valves, flumes, weirs, and yard piping. The project also consists of the addition of transfer switches with emergency generator plug, including a new trailer mounted generator, at two sanitary pump stations within the collection system.

The Work will be substantially completed within **140** calendar days after the date when the Contract Times commence to run and completed and ready for final payment within **170** days after the date when the Contract Times commence to run. Liquidated damages shall be **\$1,000.00** per day. Contract Documents may be examined at the following places:

In accordance with Ohio Revised Code §153.54, the contractor shall file with the bid a bid guaranty in the form of either: 1) a bond for the full amount of the bid, or 2) a certified check, cashier's check, or letter of credit equal to 10% of the bid.

NONDISCRIMINATION IN EMPLOYMENT

Bidders on this work will be required to comply with the President's Executive Order No. 11246. The requirements for bidders and contractors under this order are explained in the specifications.

SUSPENSION AND DEBARMENT

Under Executive Order 12549 a recipient shall not entertain the use of businesses that are listed on the "Excluded Parties List System (EPLS)" at www.epls.gov in accordance with regulation 40 CFR 32.510.

NOTICE OF FEDERAL WAGE REQUIREMENTS

Contractors are required to comply with all laws pertaining to federal prevailing wage rates issued in accordance with the Davis Bacon Act.

A Bidder may not withdraw his Bid for a period of thirty (90) days after the date set for the opening of Bids.

Bids shall be accompanied by a Bid Guarantee as required by the contract.

Bids received after the scheduled closing time for the reception of Bids will be returned unopened to the Bidders.

The Commissioners reserve the right to reject any and all Bids.
