ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Contract #12 – Cemetery Interceptor Sanitary Sewer Replacement will be received, by the Berkeley County Public Service Sewer District, located at 65 District Way, Martinsburg, Berkeley County, West Virginia 25402 until **2:00 PM** local time on **Tuesday, January 11, 2022**, at which time the Bids received will be publicly opened and read.

The approximate quantities of work to be bid upon are described as follows:

1 LS Mobilization/Demobilization, 1 LS Pre-Construction Video Recording, 1 LS Erosion and Sediment Controls, 2,845 LF Installation of Owner Supplied 18-inch PVC PS 46 Gravity Sewer Pipe, 18 EA 48-inch Diameter Manhole Base, Cone Top, Regular Casting, 5 EA Remove and Replace Existing Manhole with New 48-inch Diameter Manhole Base, Cone Top, Regular Casting, 18 VF 48-inch Diameter Precast Manhole Riser Section, 3 EA Reconnection of Existing Sewer to New Manhole, 12 EA Abandon Existing Manhole, 68 LF 36-inch Steel Casing Pipe (Open Cut), 42 LF WV DOH Type "B" Trench Repair, 105 LF HMA Driveway/Road Repair, 3,862 LF Reclamation of Disturbed Areas.

The Work will be substantially completed within 180 calendar days after the date when the Contract Times commence to run, and completed and ready for final payment within 210 days after the date when the Contract Times commence to run. Liquidated damages shall be \$500 per day.

A two envelope system will be used.

Envelope No. 1 must have the following information presented on the front:

Bid on Contract – Contract #12 – Cemetery Interceptor Sanitary Sewer Replacement
Received by the Berkeley County Public Service Sewer District

Envelope No. 2 labeled “Bid Proposal” shall also be placed inside of Envelope #1.

Envelope No. 1 will be opened first and the Bid Opening Requirement items checked for compliance as outlined on the Bid Opening Checklist on page BOR - 1 of these contract documents. If such documents are found to be in order, Envelope No. 2 “Bid Proposal”, will then be opened and will be publicly read aloud. If the documents required to be contained in Envelope No. 1 are not in order, Envelope No. 2 “Bid Proposal” will not be opened and the Bid will be considered non-responsive and will be returned to the Bidder.

A bidder may not withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

Bids shall be accompanied by a certified check or bid bond payable to Berkeley County Public Service Sewer District in an amount equal to five percent (5%) of the base bid.

Contractor is required to provide the Drug Free Workplace Certification in accordance with WV Code 21-1D-5.

All Bidders are required to have a West Virginia Contractor’s License per Section §21-11-11 of the West Virginia Code.

Bids received after the scheduled closing time for the reception of bids will be returned unopened to the bidders.

The Berkeley County Public Service Sewer District reserves the right to reject any and all bids.

A pre-bid conference will be held at **10:00 AM** local time on **Tuesday, December 7, 2021**, at the Berkeley County Public Service Sewer District located at 65 District Way, Martinsburg, Berkeley County, West Virginia 25402. Attendance at the pre-bid conference is highly encouraged but is not mandatory.
